This exam was developed to enable schools to award credit to students for knowledge equivalent to that learned by students taking the course. This exam covers topics such foundations of government and politics, Constitutional Structure and Development, Federalism and Intergovernmental Relations, Presidency and Executive Branch, Civil Liberties and Civil Rights, Domestic Policy and Foreign Policy.

The exam contains 100 questions to be answered in 2 hours.

EXAM CONTENT OUTLINE

 - b. Democratic principles underlying the Declaration of Independence and the U.S. constitutional system
 - c. Political culture (traditionalism, individualism, moralism), ideology, and values in the United States
 - d. Approaches to studying American politics (e.g., institutional, behavioral, historical)
- II. Constitutional Structure and Development 12%**
 - a. Articles of Confederation and Constitutional Convention
 - b. Founding context and constitutional debates (e.g., The Bill of Rights)

III. Federalism and Intergovernmental Relations 10.5%
